

## **Privacy Policy**

This Privacy Policy ("Policy") applies to [www.madsoaps.com](http://www.madsoaps.com), and MAD Soaps Inc ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [www.madsoaps.com](http://www.madsoaps.com). The Company's website is a Auto & Marine Detailing site. By using the Company website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Mailing address
- Email address
- Phone number

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through the Company's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ### **Sharing Information with Third Parties**

The Company does not sell, rent, or lease its customer lists to third parties.

The Company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to the Company, and they are required to maintain the confidentiality of your information.

### **Automatically Collected Information**

The Company may automatically collect information about your computer hardware and software. ### **Use of Cookies**

- Enable solely internal uses that are reasonably aligned with your expectations based on your
